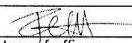
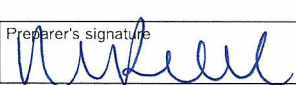

Since its inception, El Buen has been at the forefront of responding to the many social-environmental factors leading to lack of access to health care, social services, education, and nutrition. Over time, El Buen has adapted to meet the community needs that come with population growth, immigration, economic fluctuations, and the COVID-19 pandemic. This adaption has led to El Buen's comprehensive strategy centered on addressing the social determinants of health, utilizing an anti-oppressive framework to provide a "one stop shop" addressing the needs of the Latino and Spanish-speaking community. El Buen provides education, workforce development, child/adolescent development, health literacy and access to health services, a no-cost food pantry, and a community garden. In response to the pandemic, El Buen initiated its cash and rent assistance programs.
